RESEARCH OVERVIEW

Finsbury Glover Hering, commissioned by Chamber of Progress and NetChoice, conducted an online survey with Registered Voters across Arizona. The survey included:



800 registered voters in Arizona aged 18+


- Representative of Arizona's registered voter population in terms of gender, age, region, race, education, and party identification
- Fieldwork was conducted from November 2 November 16, 2021.






Arizonan voters are deeply concerned about rising prices and the economy, with Democrats especially concerned with the affordability of healthcare



When it comes to tech regulations, voters prioritize protecting consumers from scams and malware, followed by combatting misinformation online


(Q11.) Looking at the following list of potential ways that technology products and services could be regulated, which would you say are the TWO MOST important to you?

Voters attach most value to features that vet for security and viruses, followed by convenience features offered by a range of technology companies


(Q7.) How valuable do you consider the following offerings from apps or online platforms to be in your daily life, if at all?

(Q6.) Which of the following would you say you value MOST about you and your family's smartphones? Please select the three you value most.




