


Voters' views on top priorities and tech regulation







RESEARCH OVERVIEW

Finsbury Glover Hering, commissioned by Chamber of Progress, conducted an online survey with Registered Voters in:

Arizona California Connecticut Georgia Minnesota North Carolina



This included 800 registered voters in each state, for a total of 4800 interviews.


- Representative of each state's registered voter population in terms of gender, age, region, race, education, and party identification.
- Fieldwork was conducted from November 2nd November 16th, 2021.



WHAT MATTERS TO VOTERS

Voters are concerned with issues that impact their lives in a tangible way - like rising costs and the economy; the regulation of tech companies is not a priority for them


(Q1.) The following is a list of issues that some people feel are impacting the country. How concerned would you say you are with each? Answer choices: very concerned, somewhat concerned, not very concerned, not concerned at all)



As such, they want politicians addressing the economy and healthcare system; fewer than 1 in 10 see regulation of tech companies as a pressing policy need

(Q2.) Of the following list, which FIVE would you say are the most pressing issues that politicians should be addressing? Within your top five, please rate them in terms of importance to you, with 1 being "most" pressing and 5 being "least" pressing.

Top concerns faced by voters:



Rising prices and inflation ranks as a top-5 concern for those 55 and older (62%)

COVID-19 ranks as a top-5 concern for Black Americans (54%) and Democrats (60%)

For Democrats, COVID-19 (60%) is the top concern, followed by climate change (55%)




ATTITUDES TOWARD TECH REGULATION

MOST important tech regulations (top 2 most important):




Combatting misinformation online is an especially critical priority for Democrats (36%)

Voters attach most value to features that provide protection and security, as well as convenience for users


(Q7.) How valuable do you consider the following offerings from apps or online platforms to be in your daily life, if at all?

Security, convenience, and privacy are top valued features provided by smartphones


(Q6.) Which of the following would you say you value MOST about you and your family's smartphones? Please select the three you value most.








RESULTS BY PARTY IDENTIFICATION

Republicans and Democrats have starkly different priorities, but agree that the regulation of tech companies isn't one of them
